EACS/Esperanza Joint Board Leadership Collaboration

Rev. Roger Zepernick has informed a group of EA Board members will meet with a group of Esperanza Inc. Board members sometime in February to discuss each board's agenda moving forward.

Monthly Financial Report

David Rossi reported that the finance committee met last week to discuss the latest financial report which was emailed to board members with the other December board documents.

Ms. Carmen Rocha asked about the school district receipts. David Rossi informed that several special education students were not identified in the district's student information system. The school is presently reconciling both student information systems to ensure they match each other and will receive revenue as appropriate for any student in the reconciliation process.

PVAAS Data Report

Ms. Lori Walinsky informed that the Pennsylvania Value Added Assessment System (PVAAS) takes into account past PSSA performance and gives students a prediction on how well they would do. The school is judged on how well students perform in relation to the predicted success of each student and the school as a whole. Esperanza Academy received a Dark Blue rating in all subjects and grade levels. Dark Blue is the highest rating possible and represents "Significant evidence that the school exceeded the standard for PA Academic Growth".

Elementary School Instruction Report

Ms. Kim Chung spoke to the progress students are making in their reading levels. Students took their first ELA and math benchmarks. These benchmarks also help teachers view data on students' progress toward proficiency in the standards.

A total of 95 families attended the Parent-Teacher conferences last month. At the end of the last school year 22% of students were reading at or above grade level. At this point-in-time 35.3% of students are reading at or above grade level.

Middle School Instruction Report

Ms. Tania Diaz informed that student intervention is taking place until the end of the school year. The Classroom Diagnostic Tool (CDT) data has been used to identify and place students in the Academic Intervention Program. The PSSA countdown will begin in January 2019. Data from students' benchmarks will be reviewed tomorrow, December 14, 2018 during the professional development.

High School Instruction Report

Mr. Jorge Calixto spoke to implementing the Classroom Diagnostic Tool (CDT) benchmark exam to 9th graders. A testing coordinator has been identified and will be spearheading the benchmark test.

The PVAAS data will be shared with teachers' tomorrow during professional development in order to discuss areas of growth. The administration has identified students who will be getting SAT and PSAT tutoring.

College Enrollment/Persistence Report

Ms. Rebecca DiSalvo presented data from the National Student Clearinghouse (NSCH) which tracks students' college attendance nationwide and covers 93% of all US college enrollments. For the class of 2018 a total of 84 students (54%) have enrolled in a post-secondary institution. Discussion was had on the reasons students may select a 2-year institution.

PA Future Ready Index

Mr. David Rossi reviewed the use of PA Future Ready Index report which provides information on any schools' performance. This tool is replacing the School Performance Profile (SPP).

The Board asked what is the city and state average for ELA/Mathematics and Science. Ms. Lori Walinsky informed data would need to be researched.

Ms. Lori Walinsky reviewed the results and goals of the PA Future Ready Index. Students meet or exceeded statewide goal in ELA/Literature and Science/Biology 24.2%. Annual academic growth expectations in PVAAS were meet or exceeded: ELA/Literature 100%, Mathematics/Algebra 100%, and Science/Biology 100%.

Ms. Lori Walinsky and Ms. Karen Sergovic are investigating how the state came up with the 20.2% proficiency rate for English Language Learners. There are also goals for college and career which is broken out in the following sections: high school graduation rate, industry based learning, rigorous courses of study, and post-secondary transition to school, military or work.

The Board asked why college courses (dual enrollment) is presently missing on the rigorous courses of study. Ms. Lori Walinsky will investigate and follow up.

Benchmark Testing Report

Mr. David Rossi has informed that the data will be included in the Mid-Year report which will be presented in the February 2019 meeting.
