Greeting

Rev. Roger Zepernick welcomed all and called the meeting to order at 5:35pm.

Approval of Minutes

HS Director of Instruction Report

Mr. Nathaniel Stringfield reported that the first 9th grade orientation took place on June 11th. Approximately 175 students were represented out of 222. Parents had the opportunity to tour the building and ask questions regarding courses, expectations and graduation requirements. A session was held separately with parents to discuss parental involvement and how to meet students' needs.

Students successfully took the PSSA & Keystone exams. Results will be made available sometime in July. A report will be provided to the Board in August reflecting student outcomes.

MS Director of Instruction Report

Mr. David Solivan reported that Classroom Diagnostic Tools testing (CDT's) were administered to all incoming 6th grade students. Data will be analyzed to determine appropriate class placement and

intervention decisions for all core content areas.

Students successfully completed their promotion requirements therefore, no students were retained for the present school year. Approximately, 37 students who ended the year with one or two failing courses will be participating in the extended academic intervention program from June 17-28th. There student will be officially promoted upon completion of the program.

The eighth grade awards assembly was held on June 5th in the middle school gym. This is the first year the award assembly was opened to parents. A parent initiated a petition requesting parent participation in the award assembly. Administration was able to make the necessary changes for parents to participate and over 300 people were in attendance.

ES Director of Instruction Report

Ms. Kim Chung reported that elementary school is preparing students for the third grade PSSA. there has been continual communication between parents and staff members in order to help students meet their academic and behavior expectations in the classroom. The student anthology (published book) will be presented at the Board retreat.

Finance Committee Report/Monthly Financial Report

Mr. David Rossi reported on the items reviewed during the Finance Committee Meeting on Tuesday, June 18th. Discussed during the meeting was the March 2019 financial report which reflects a point-in-time surplus of \$265,000. Affecting the year-end report is the per pupil allotment which was changed by the School District of Philadelphia. This change would bring approximately \$100,000 in additional revenue which will be received by June 25th.

FY 2019-20 Budget

Mr. David Rossi informed that total revenue for the 2019-2020 budget is a little over \$26 million. The budget enrollment is projected to be 1633 when compared to 1573 in the prior school year. Now that the charter has been approved the cap is now 1855 for the FY 20. Administration has made the decision to increase enrollment to 1633 and replace any student who withdraws over the summer months.

The per pupil allotment was announced by the School District of Philadelphia in June. The regular education allocation is \$10,156 and special education allocation is \$28,979.

Ms. Nancy Santiago-Negron asked how students are replaced if there is a vacant seat. Mr. Rossi replied that there is a waitlist for each grade level.

Budgeted expense reflects a placeholder on salary increases. A few existing staff members will have enhanced roles thereby budgeting a salary adjustment. We are budgeting additional staff that can serve the budgeted enrollment.

New Positions include:

- High School Director of Student Development To better match the ratio of administration in other grades.
- High School Math Teacher Additional Alg 1 Support
- High School Science Teacher to account for increased offerings
- Elementary School Core Subject Teacher Increased intervention for low level students.
- Elementary School Part Time School Climate Officer needed to provide additional security in the Elementary School building
- Middle School Emotional Support Teacher Needed to support the current needs of our Special Education students
- Middle School Therapist, Part Time Increased load of counseling for Special Education students.
- Middle School Math and Reading Specialists Needed to support lower level Math and Reading students
- Middle School Specials Teacher In order to execute the exposure to additional majors at the MS level additional staff is needed.
- Special Projects Director This position was cut 2 years ago. Providing additional support and management for central administration.

Positions moving from Part-Time to Full-Time:

- High School Social Studies Teacher needed due to meet enrollment demands
- High School Music Teacher needed to meet course requests.
- Elementary School English Language Development Paraprofessional needed to provide additional support for English Learners at the ES level.
- Administrative Assistant to English Language Development Department Additional support for the ELD Department

Administration and Board members discussed challenges to increase health costs.

Total Expense is \$26,080,504.

Contract Approvals

- 1. Flynn O'Hara: the administration is recommending the approval of the contract between Flynn O'Hara and Esperanza Academy for the purchasing of school uniforms. Attached are the prices by school for each piece of the uniform.
- **2.** Consulting Agreement: the administration is recommending the approval of the contract between Erin von Zuben and Esperanza Academy Charter School for providing evaluations for students. Rate per evaluation \$900. Total evaluations, approximately 9. Total not to exceed \$8,100.
- **3. Student Number 233-188:** EA has entered into a settlement agreement for A.C. Student Number 233188. The settlement includes attorney fees at a cost of \$7,000 and \$39,000 for compensatory education.
- **4.** Educ8Every1, LLC: the administration is recommending the approval of the contract between Educ8Every1, LLC and Esperanza Academy Charter School for the developing of ELD Curriculum and enhancing content area curriculum for English Learners (EL). Total not to exceed \$5,000.
- **5. LinkIt**!: the administration is recommending the approval of the contract between LinkIt and Esperanza Academy Charter School for the use of assessment management and analytics platform software for the 2019-20 school year, subject to legal review. **Total yearly cost** \$24,179.
- **6. The Salvation Army**: the administration is requesting approval of the contract between Esperanza Academy and The Salvation Army for the lease of the space at 3150 N. Mascher Street for the elementary school. Annual lease fee is \$261,179.04 payable in twelve (12) monthly installments in the amount of \$21,764.92 for the 2019-2020 school year.
